Abstract: The author presents shortly the main innovative features of the concepts and paradigms achieved by using the prefixes “eco-bio-geo-“ attached to the words - phrases regarding: economics, strategy, management, sectorial policies, technologies, etc. It exemplifies as a priority in the specialized literature, and especially scientific works of the Danubian Research and Studies Center-Fourth Europe, the combined use of different phrases, concepts and paradigms integrated two of the three specified prefixes attached to the same basic words already mentioned (e.g. eco-bio-economics, geo-eco-management and so on). The Fight against Tax Fraud and Tax Evasion

Abstract: Collecting taxes and fighting against tax fraud and tax evasion are competences of EU Member States. In a globalized world, with globalized actors, Member States would often need more global means to collect taxes due. The European Union provides a framework and offers instruments to handle cross-border tax issues including potential tax evasion. On 2nd March 2012, the European Council called on the Council and the Commission to rapidly develop concrete ways to improve the fight against tax fraud and tax evasion, including in relation to third countries and to report by June 2012. In April the European Parliament adopted a resolution echoing the urgent need for action in this area.

Considerations on Maritime and River Courts in the Romanian Judicial System

Abstract: The study seeks to highlight the way the Romanian state concerned itself and continues to ensure professionally solving disputes that arise about sea and river transport. The complexity and specificity of this sector of economic activity require, the opinion and decision of experts in the field of reference. Given these considerations and focusing on the purpose of other European countries legislation, the modern Romanian state integrated itself the European context, adopting legal rules able to ensure fair and equitable resolution of conflicts in this field. The study tracks the evolution of the Romanian river and maritime courts driven by the economic situation of different times. Beyond these, it must be concluded that, regardless of the material conditions, political views or circumstances, Romania - State bordering a large European river and a geostrategic importance sea, must have maritime and river courts.

The Constitution of the Moldavian Parliament. Structural and Functional Evolution

Ilie Girnet, Cahul State University “B.P. Hasdeu”, Republic of Moldova

Abstract: In the late 1980s, the liberalization of USSR led to the emergence of long-repressed nationalist movements and ethnic disputes within the diverse republics of the Soviet Union. Along with several other Soviet republics, Moldova started to move towards independence. Republic of Moldova is a unitary parliamentary representative democratic republic. The country's supreme central legislative body is the unicameral Moldovan Parliament, which is rather young, dating from 1990, as the first democratic elections for the local parliament were held in 1990. The Parliament adopted the Declaration of Sovereignty of the „Soviet Socialist Republic Moldova”, which, among other things, stipulated the supremacy of Moldovan laws over those of the Soviet Union. In 1991, the Moldovan parliament changed the name of the republic from „Moldavian SSR” to „Republic of Moldova”. Moldova then seceded from the USSR and became a sovereign, independent state. Although the young Moldovan parliament experienced some crisis moments, it is considered to achieve success in establishing the legislative basis of the newly formed state. In Moldova, as in other former Soviet Republics, the Parliament is a creation of social practice, a result of the dissolution of the Soviet Union. Based on these beliefs, we can agree that the need for such research is justified. Parliamentarism as a form of government and political influence in studies of both historical and contemporary points of view is a subject of this presentation. From this point of view, in the modern world, we are increasingly seeing a persistent manifestation of democratic functioning and organization of power, based on the fundamental principles of law. The Constitution of the Republic of Moldova is that country's supreme law. In general, we should note that

As holder of public power entrusted by the community that elected them, they are obliged to respect the Constitution and laws, to protect interests of those communities, respecting the national interest, to support voters in solving problems, to worry about the prosperity of the community they belong to and which has assured the mandate to them. The purpose of this article is the analysis of the normative acts regulating the status of local elected persons, including his rights and obligations, to clarify and resolve some unclear cases related to this area. Because the accurate determination of these rights and obligations for local elected person depends the efficient activity of his in particular and the good governance of local government in general.

Abstract: The basic principles stated and applied by the European Convention of 1950 and by the common constitutional traditions of the member states are considered general principles of the Law of the European Union regarding human rights. That is why we cannot talk about the juridical protection of human rights without being well-acquainted both with the text of the European Convention on human rights signed in Rome in the year 1950 and with the text of the Constitutions of the member States, which is – or should have been – in accordance with the framework of the common constitutional traditions. These general principles and norms should not only be known, but also included in the texts of the Constitutions of the States of the European Union, through which they should also assure and grant the juridical protection of the human fundamental rights and liberties, that have not always been respected in the spirit of the principle stated by the European Convention and by the constitutional Traditions of the states of the European Union.

International Covenant on Civil and Political Rights

Abstract: According to the Covenant on Civil and Political Rights adopted by the United Nations, in 1966, the human being who enjoy his civil and political rights, enjoy in fact that “humanitas dignitas” (human dignity), since these rights derive from this. That is why this Covenant stipulated that the States parties are obligated to assure both the recognitions of these rights and their exercise and juridical protection.

Analysis of the Opportunity to Include Intelligence Officers in the Category of Special Criminal Investigation Bodies

Bogdan Bîrzu, Titu Maiorescu University, Romania

Abstract: Informative activity is, in fact, a confrontation between investigative structures and the criminal organizations, in which each of the camps is collecting data about "opponent" to achieve their targets. Given this confrontation, the success of the investigative activities is essentially dependent on the capacity of the judicial body to communicate, to procure information needed to conduct the investigation. High quality legal information, transmitted in real time and used when appropriate can have a decisive role in solving a case. To this end intelligence officers collect and store in databases specific information about crimes and their perpetrators, verify it through investigative activities, identify and provide the probation means to be given in the criminal prosecution phase.

Comparative Characteristics of Technology Transfer in Developed Countries

Natalia Palii, Academy of Economic Sciences, Chisinau, Republic of Moldova

Abstract: The research into innovation transfer in the global economy is a very urgent issue under the modern conditions of development of any country. Comparative characteristics of technology transfer in such countries and regions as the USA, EU, Asia, presented in the article, permit us to detect certain patterns of this process inherent both in developed and developing countries. The analysis made in the article can be useful for developing technology transfer processes in the Danube countries' economy. The analytical method used in this research allowed us to determine the factor that is crucial for the growth of the world market of high-technology products and services. The analysis was conducted on several criteria such as the level of expenditure on R&D in the whole global economy, as well as in individual countries and regions. Besides, there were taken into account the added value of high-tech industries and the share of expenditure on R&D in total production costs. The conclusions regarding the effectiveness of funds allocated for scientific research and experimental development in the U.S. can be drawn on the basis of data presented in the paper on the amount of added value of the U.S. high-tech industries.

Providing the conditions for shipping in good conditions, suitable for various types of ships for such navigable artery, it would result, in addition to the substantial increase in the volume of transported goods, the diversification of these goods including the operation of those with high value and also the development of a variety of activities connected to water transportation.

In comparison with the statistics of weather conditions for 1961-1990 and 1991-2000 the climatic situation in 2001-2012 testifies to significant increase in an evaporability (19, 5 %) and deficiency of water consumption of the soil (41, 9 %). As a result some changes of agrolandscapes were noticed in the region, connected with mass emergence of weeds, which are atypical for the region: *Ambrosia artemisifolia* L. *Lactuca tatarica* L, *Anisantha tectorum* Nevski,

One of Zeletin's stakes was to prove that the economic and political evolution of the Romanian area was the results of being entrained, at the beginning of the 19th century, in the great world trade, who symbol and engine was

the British Empire. From this perspective, Zeletin defended a different attitude from other Romanian historians, sociologists or economists, by underlining the major historical role of Great Britain for the Romanian history in the first half of the 19th century and by a positive valuation, from an ampler historical perspective, of the complex socio-economic processes from the Romanian society, processes that, in most cases, are negatively evaluated. Zeletin's opinions can be easily understood if one compares the Romanian realities with those from South America, from the area of the La Plata River (Argentina, Uruguay). Both regions had a similar status in the world economy at the beginning and middle of the 19th century, being neutral economic zone, supplied of agricultural products for the great powers, which affirmed on an international plan benefiting from the rivalries between the great powers. If at the beginning the fact that these backward areas were connected by trade to a capitalist power such as Great Britain was a good one, from the second half of the 19th century this was a burden, out of which they wanted to escape through protectionism and the creation of a national industry. Not accidentally, Mihail Manoilescu's works were highly successful in Latin America. In the same time, one of the aims of this paper is to stress the importance of the Romanian ports of Galați and Brăila for the Romanian history of the 19th century, taking into account the example of two famous South American ports: Buenos Aires and Montevideo.

The Conflict between Tito and Stalin (1948-1953) and its Consequences upon the Danube

Abstract: The Soviet Union couldn't rejoice for long for the success obtained at the Danube Conference from Beograd (30-th of July – 18-th of August 1948), due to the fact that its relations with Yugoslavia rapidly deteriorated as a result of the conflict that burst between the leaders of the two nations. Until the death of the Soviet dictator (March 1953), the conflict between Tito and Stalin seriously hindered the transport on the Danube, hence being one of the factors that assisted the collapse of the naval transport on the Danube, after WWI. The conflict between Stalin and Tito bore consequences also upon the functioning of the Commission of the Danube, the new institution created by the Communist countries through the Agreement from Beograd (18-th of August 1948), with the aim of regulating the navigation on the river. At the same time, in order to redress its lost prestige, the Soviet Union fervently supported the project of the Danube – Black Sea Channel and it forced the Romanian authorities to engage in huge expenditures for digging it. Nevertheless, the conflict also engendered some positive results. After Stalin's death, the new leader from the Kremlin, Nikita Sergheevici Hrușcirov, approached

Along with unification of Romania there is the need to make a number of demographic studies of territories which became the part of the Kingdom. As the result were performed a number of demographic studies both at the country and county level. The studies in question were reflected in official bulletins counties and in the publication of general censuses made in the 1930s and 1941. Doing an analysis of these sources we can make an analysis of the demographic evolution of the county Ismail at all aspects (ethnic, by age, occupation, etc.).

Abstract: Nowadays we grant a great importance to the clothes we wear from the moment we buy or make them, to the moment we decide if they are appropriate with our personal style, the place where we wear them or when we use them. If the XIXth century tries to preserve the tradition with great accuracy the way it was transmitted from generation to generation, in the tumultuous XXth century we attend to the birth of a real industry of fashion. Some reminiscences remain, however, which gives us the opportunity to draw up a study in this regard. The present paper intends to add information regarding the folk costumes in Galati County, especially in the XIXth century. It is a short presentation of some of the most traditional clothes such as: skirt, apron, hood, shirt male and shirt female, decorative designs, footwear; without claiming to have finished the subject we intend to go on with further research.
